USE FOR ALL PLANTS & TREES: Houseplants, Vegetables, Fruits, Ornamentals, Trees, Shrubs and Succulents.

CONTROLS: Aphids, Whiteflies, Mealy Bugs, Mites, Powdery Mildew, Downy Mildew, Blight, Canker, Black Spot.

DIRECTIONS FOR USE: Shake well before and during each use. Thoroughly spray leaves and stems until there is runoff. Spray outdoor plants early in the morning or evening to avoid the hottest part of the day. Do not apply in temperatures over 90°F. If a second application is necessary, wait at least 5 days prior to reapplication. When using as a repellent, reapply every 7-10 days. For additional safety, avoid use when pollinators are active.

PRECAUTIONARY STATEMENTS / FIRST AID: Avoid getting product near extreme heat, sparks and open flames. Avoid getting in eyes or on skin or clothing. Harmful if swallowed. Direct eye contact may cause irritation. Impervious gloves are recommended to prevent prolonged skin contact. If contact occurs, wash with large amounts of soap and water for 15-20 minutes. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.

STORAGE: Keep product in its original container in a cool, dry location away from direct sunlight. Store in temperatures between 65°F and 80°F. Do not freeze.

INSTRUCCIONES DE USO: Agitar bien antes de cada uso y durante el uso. Cubrir la planta a tratar cuidadosamente, incluyendo las hojas y tallos, hasta que oscurra. Rocíe las plantas exteriores temprano en la mañana o por la noche para evitar la parte más calurosa del día. No aplicar en temperaturas de más de 90°F. Si se necesita una segunda aplicación esperar al menos 5 días antes de volver a aplicar. Cuando se use como repelente, vuelva a aplicar cada 7-10 días. Para mayor seguridad, evite su uso cuando los polinizadores estén activos.

PRECAUCIÓN/PRIMEROS AUXILIOS: Evitar colocar el producto cerca de calor extremo, chispas y llamas expuestas. Evitar que entre en los ojos o toque la piel o la ropa. Peligroso si se ingiere.
