MIXING INSTRUCTIONS: Prior to mixing, agitate the concentrate well. Dilute the concentrate according to the desired usage, preventative or curative. PREVENTATIVE: Mix at 0.25% or 10 mL/gal. Thoroughly spray the leaves and

stems of the plant you are treating until there is runoff. Shake during use. Repeat this process every 7 days.

CURATIVE: Mix at 1.0% or 40 mL/gal. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Shake during use. Repeat this process every 3-5 days, as necessary.

DIRECTIONS FOR USE: For outdoor and greenhouse application, spray plants early in the morning or evening to avoid the hottest part of the day. Avoid spraying in temperatures over 90°F. For indoor application, keep lights and fans off for 2-3 hours after spraying.

No limitation on the number of applications per growing cycle. No need to add a wetting agent. For additional safety, avoid use when pollinators are active.

PRECAUTIONARY STATEMENTS/FIRST AID: Avoid getting product near extreme heat, sparks and open flames. Avoid getting in eyes or on skin or clothing. Harmful if swallowed. Direct eye contact may cause irritation. Impervious gloves are recommended to prevent prolonged skin contact. If contact occurs, wash with large amounts of soap and water for 15-20 minutes. 
